### **2. MODEL'S PERFORMANCES, UNDERTAKINGS AND OTHER DUTIES**

(2.1) The Model needs always to be easily contacted for receiving notification of casting and job assignments and must go to the assignment arranged by the management. In the event that the Model neglects or fails to go to castings or misses booking shootings, Model will bear all the Expenses of the particular shoot.

(2.2) The Model should use Silverline Model's book during period of contract term, take and fill out the Job vouchers and keeps it for every job.

(2.3) The Model shall observe and know the laws of Shoot location, agree to follow and Comply with Silverline Models rules and regulations concerning all aspects of the Model's modelling activities in shoot site.
